Why Ilia's Path?

Ilia Chavchavadze is a figure in Georgian history whose thoughts and vision for statehood remain relevant and highly pertinent even after a century. Ilia was a public figure with a broad outlook that encompassed everything fundamental regarding the establishment and building of a state.

Ilia was not only a leader of the national liberation movement and a dedicated advocate for national and civic consciousness, but also one of the founders of Georgian schools and the first public organization—the "Society for the Spreading of Literacy Among Georgians," which saved Georgia from outright Russification. Together with like-minded individuals, Ilia also established the first financial institution in Georgia—the Land Bank. Ilia was a preacher of equality and a key figure in establishing the judicial system, having served as a judge himself.

Ilia's ideas and actions extended into every sphere important to society—education, culture, economy, self-governance, the concept of equality, women's rights, and civic activism. He left us a formula for national identity—"Homeland, Language, Faith"—and simultaneously, his generation introduced modern European ideas to Georgia, shaping the future trajectory of an independent Georgia. Today, we continue to follow Ilia's path, striving to build a state founded on his ideas.

Why the Marshall Plan?

During the rule of -"Georgian Dream", Georgia has faced harsh realities. The population is increasingly impoverished, and thousands of our citizens are leaving the country with their families to live abroad. The criminal policies of the ruling party have completely halted the European integration process, turning Georgia into a weak, vulnerable, and unpromising country under Russian influence. After a change in power, Georgia urgently needs systemic reforms and innovative solutions for rapid economic growth.

Our action program is called the "Marshall Plan". In the last century, after World War II, the European Reconstruction Plan (the "Marshall Plan") saved European countries from poverty and hunger, spurred unprecedented economic growth, protected them from the spread of Soviet influence, and initiated the process of European unity, laying the foundation for the long-term stable and democratic development of European countries.

Our Marshall Plan aims to address similar challenges—rapid economic growth for Georgia, protection from increased Russian influence, and accelerated European integration for peace, democracy, and prosperity. The Marshall Plan includes rapid economic development, higher pensions, decent jobs, and a swift implementation of major infrastructure projects such as the deep-sea port and the city of Anaklia, a logistics hub in Kutaisi, and many other innovative projects. The Marshall Plan represents billions in investments in the Georgian economy, positioning the country as a regional leader.



A MESSAGE TO FELLOW CITIZENS

Georgia faces a severe crisis. We are losing our statehood. We are losing the prospect of a better life. Unemployment, high prices, and inflation are making daily life unbearable for our citizens. We are losing our young people, who are leaving Georgia for foreign countries in search of better opportunities. Most distressingly, we are losing our country because we have a government that serves Russia, not Georgia.

The "Georgian Dream" government has consistently prioritized Russian interests over Georgia's. By passing the so-called "Russian Law," the ruling party turned its back on the historic choice of the Georgian people and blocked Georgia's path to European integration. Bidzina Ivanishvili became wealthy in Moscow; he is a Russian oligarch, and for him - Russia is a natural environment. His government opened the doors for the mass influx of Russians into Georgia. To pass the "Russian Law," the government dispersed peaceful protesters, fined them, and arrested them. Violent groups brutally attacked activists. The policies of "Georgian Dream" have long been aligned with the Kremlin's interests rather than those of the Georgian people.

We must end a government that serves Russia! And we must not allow the return to power of those leaders who, in the past, violated the rights of our fellow citizens severely. For 20 years, only two parties have ruled Georgia; both have abused power and disappointed the people.

Now, a real alternative exists! "Strong Georgia"—the unity of "Lelo," "For the People," "Freedom Square," and "Citizens"—is a new force with young, clean-slate leaders, who have professional experience, bold ideas, and a commitment to building a strong Georgia.

We present to you the "Strong Georgia" action plan—"Ilia's Path," based on Ilia Chavchavadze's timeless and relevant vision of strengthening the foundation of the Georgian state and building a new, strong, distinctive, and successful Georgia upon it. This plan details our commitments to the Georgian people in every area—employment, affordable prices, quality healthcare, high-standard European education, export-oriented agriculture, an independent judiciary, and more. We must create a modern state based on the rule of law, with a strong middle class that will become the political, economic, and cultural center of the region.



Above all, this document includes the three main promises of "Strong Georgia":



European Union Membership and a European Future

Strong Georgia has a detailed plan to ensure Georgia's EU membership in a short time. Our plan will swiftly fulfill the nine recommendations from the EU. Georgia will open and effectively conduct negotiations on EU membership. Georgia will lead the wave of EU enlargement. We have signed the President's "Georgian Charter," which represents a multi-party agreement directed toward this goal. Georgian citizens, entrepreneurs, and emigrants will experience tangible benefits from the EU during the accession process.

200,000 Jobs and Fair Wages

Under the "Georgian Dream", Georgia has 200,000 fewer jobs than it would have under normal employment policies. Strong Georgia will create 200,000 new jobs through the implementation of mega-projects such as Anaklia, which the "Georgian Dream" blocked. We promise to create better infrastructure with European "green building" standards; we promise paid internships for all graduates who wish to participate.





Furthermore, **Strong Georgia** will establish a standard of fair compensation for the first time under the conditions of an independent Georgia. As a result of the calculation of the living wage with the new model, the amount of the minimum wage will be determined, which will be fair to all employees. Fair remuneration for work is a necessary prerequisite for a dignified life.

1,000 GEL Pension

"Strong Georgia" will raise the minimum pension to 1,000 GEL and adjust it annually according to inflation so that our senior citizens can live with dignity.



We hope you will take the time to familiarize yourself with "Strong Georgia's" action plan—"Ilia's Path"—and join us and thousands of other fellow citizens in the crucial battle that lies ahead. PRIORITY #1:

Ensuring EU Membership and a European Future

Strong Georgia believes that the future of our country lies in Europe. The "Georgian Dream" government has tried to block Georgia's European path through the mass influx of Russian emigrants, passing the "Russian Law," violating EU standards in elections and human rights, and granting the Kremlin veto power over everything from the Anaklia project to our foreign policy. The European Commission has stated that the actions of the "Georgian Dream" "violate the fundamental principles and values of the EU," distancing Georgia from EU membership. Under the "Georgian Dream", Georgia has lagged behind Ukraine and Moldova on the path to EU accession.



Strong Georgia's top priority is to end the "Georgian Dream's" treacherous subservience to Russia and quickly lead Georgia toward EU membership and a European future. The European choice is a national choice!



Strong Georgia has a nine-point plan by which our country will swiftly meet the requirements set by the European Commission to begin the EU membership accession process. We will repeal the so-called "Russian Law," which has become the main obstacle to Georgia's European integration.





We will reform the judicial and electoral systems according to European standards and in line with the President's Charter, which was signed by opposition parties. We will eliminate corruption and de-oligarchize our political system. We will align Georgia's foreign policy with European goals and objectives.

Strong Georgia will also stop the mass influx of Russians and Kremlin's influence in our country, which was facilitated by "Georgian Dream". "Georgian Dream" allowed the uncontrolled entry of Russian emigrants, who bought land and real estate, opened businesses, and increased prices; our cities are filled with Russians who, in many cases, have replaced Georgians in jobs. This uncontrolled situation will be ended by the **"Georgia Protection Act"** we have prepared, which will:

- 1. Restore visa regulations for Russian citizens; protect jobs for Georgian citizens;
- 2. Take steps to prevent Russia's growing political and economic influence; issue appropriate acts to protect the interests of Georgian citizens and the security of the Georgian state; limit the activities of Russian "soft power" in Georgia;
- 3. Synchronize the country's policy with the EU measures adopted against Russia's aggression in Ukraine.

Strong Georgia believes that the Georgian people deserve a truly European life, which means more jobs, better wages, higher pensions, modern healthcare, strong schools, a clean environment, and guaranteed protection of dignity and fundamental rights. Strong Georgia has a concrete plan that will lead our country toward this future—quickly, steadily, and irreversibly.

PRIORITY #2:

Creation of 200,000 Jobs; Fair Minimum Wage for Employees

The policies implemented by "Georgian Dream" have cost our country and people jobs that are crucial for economic growth and securing a dignified future for our youth. Among other promises, Bidzina Ivanishvili pledged to establish 100 new factories, but this was not fulfilled, leading to impoverished and depopulated towns and villages. Georgia currently has 200,000 fewer jobs than it should have if "Georgian Dream" had achieved employment levels typical for countries like ours.



Strong Georgia will eliminate the deficit of 200,000 jobs lost due to the policies of the "Georgian Dream." Our detailed plan will create fairly compensated jobs and new employment opportunities for the youth.

We will complete the Anaklia deep-sea port and other megaprojects. The first and most important step in our employment plan is the rapid construction of the deep-sea port in Anaklia. The port and the city of Anaklia will generate tens of thousands of new jobs. The "Georgian Dream" government deliberately delayed and halted this project to satisfy Putin's demands and Ivanishvili's personal political interests. Strong Georgia will revive the Anaklia project and complete it within four years.



We will ensure that Georgian citizens are primarily employed in the jobs created in Anaklia. Besides Anaklia, **Strong Georgia** will initiate and complete other large-scale economic and smaller projects across the country, which will create jobs and new opportunities for our fellow citizens, including:

- A logistics and financial center in Kutaisi;
- Modern IT schools in every region (similar to what has been done in Tsalenjikha);
- Development of new tourist destinations in regions like Svaneti, Khevsureti, and Tusheti.

Green, EU-standard construction technologies: Our citizens are severely affected by the fact that many significant projects are implemented through corrupt decisions, outdated equipment, and technologies that do not meet the standards. We have seen the East-West highway remain incomplete due to corrupt deals and poor management; the Shovi tragedy showed us the high price our people paid due to a broken system of protection and prevention, lack of development standards, and the irresponsible and indifferent attitude of the government. Strong Georgia will implement megaprojects using modern European "green" construction practices tailored to the interests of people and the environment. This includes transparent tender conditions and support for Georgian companies to be efficient and environmentally conscious, and ensure the safety of people.







Paid Internships – First Job for Every Graduate

It is very difficult for young Georgians to find employment, and as a result, many leave the country. **Strong Georgia** will create paid internship opportunities—a "first job" for every university graduate who wishes to participate. Young people who have studied hard should have the opportunity to gain work experience and acquire new skills. Internships will be available in both the public and private sectors, providing graduates with valuable professional skills and experience for their future careers.

Fair Minimum Wage for Employees

People who work deserve adequate pay to live with dignity. For the first time since independence, **Strong Georgia** will establish a standard for fair and decent wages, ensuring that employees can meet their basic needs.

PRIORITY #3:

Increasing Pensions to 1,000 GEL and Annual Adjustments According to Inflation

Strong Georgia will ensure a dignified and stable pension for all pensioners. We will raise the minimum pension to 1,000 GEL and adjust the rate annually in line with inflation.


There are over 830,000 pensioners in Georgia, with more than 98,000 relying on social assistance.



During its 12 years in power, the "Georgian Dream" government has failed to adequately support pensioners. Since 2013, prices have been rising rapidly in Georgia, particularly in the last two years when prices increased by double digits. The cost of food and medication, which are vital for pensioners, has been rising even faster. "Georgian Dream" has been unable to provide our pensioners with dignified support.

Recently, "Georgian Dream" increased pensions, but only for those employed within government structures (such as law enforcement, parliamentarians, etc.), while everyone else struggles to survive. If higher pensions are guaranteed for parliamentarians or police officers, the same should apply to teachers, factory workers, and farmers.

"Strong Georgia" will increase pensions within a realistic, citizen-focused budget. The pension increase will be fully funded, made possible by the high economic growth guaranteed by the "Marshall Plan", the elimination of corruption, reduction of bureaucratic expenses, cuts to the budgets of the Ministry of Infrastructure and the Public Broadcaster, and higher taxation of the gambling industry.

Economy

- Under the rule of "Georgian Dream," the country has lost 200,000 jobs.
 In an economy the size of Georgia's, it costs \$30,000 to create one job.
 Strong Georgia will address this deficit with \$6 billion in direct foreign investment.
 Strong Georgia will ensure fair compensation for every citizen!
- The construction of the Anaklia Port and the city of Anaklia will be completed; infrastructure megaprojects will begin nationwide.
- To develop the capital market in Georgia, an international stock exchange will be established, providing an alternative source of funding beyond banks.



Conditions Necessary to Achieve the Marshall Plan's Economic Goals

1 Improvement of the Business Environment

To achieve the economic goals of the "Marshall Plan" and fundamentally improve the investment climate in the country, the government must create conditions that support business operations and growth. To enhance the business environment, the government must ensure macroeconomic stability, increase the productivity of the private sector, reduce and simplify regulations, maximize transparency, and significantly improve access to financial resources.

2 Development of the Labor Market

In 2021-22, 224,000 people emigrated from Georgia, most of whom are of working age and have highly qualified skills. As a result, the number of qualified workers in Georgia's labor market has decreased, which greatly harms the country's investment attractiveness.

The formation and development of a full-fledged labor market will lead to the continuous development of employees and increase their competitiveness and productivity. In Georgia today, the alignment of the workforce's qualifications with market demands is particularly problematic, negatively affecting employment. This issue stems from the inefficiency of the higher education system. Moreover, professional retraining systems need significant improvement.

To support a full-fledged labor market, the new government will implement a fundamental reform of education and align it with market demands. Additionally, high-paying jobs will be created through double-digit economic growth, encouraging our citizens to stay in the country and prompting Georgian emigrants to return home.

3 Promotion of Innovation

Upon coming to power, Strong Georgia aims to focus on innovation and increase intellectual and entrepreneurial competitiveness alongside traditional competitive advantages.

Lack of innovation in certain sectors of Georgia's economy leads to low productivity and, consequently, low competitiveness of produced goods. A prime example is Georgia's agricultural sector, where the country lags in average productivity in nearly every sub-sector compared to many other nations, making it heavily dependent on agricultural imports.

Therefore, a fundamental reform of education is crucial, along with fostering innovative thinking among young people and teaching coding and robotics from an early age.

4 Development of the Capital Market

Georgia will become a financial center in the region. The rapid growth of the country's economy is directly linked to the development of a capital market, which is practically non-existent in Georgia today. With the capital market reform, Georgia will become a financial center with a strong stock exchange, creating long-term investment funds and new jobs in the country. The Georgian Stock Exchange will partner with the London Stock Exchange.

5 Establishment of Effective Arbitration

To protect the interests of local and foreign investors, attract new investments, and improve the business environment, one of the most important issues is the establishment of private arbitration in Georgia. Given the current challenges related to the independence of the judiciary in Georgia, it is crucial to establish arbitration in collaboration with the London Court of International Arbitration. There are precedents for such cooperation with the London Court of International Arbitration in Central Asia and the Middle East.

FOR SMALL AND MEDIUM ENTERPRISES

- A \$3 billion guarantee fund will be established to support businesses with long-term and favorable financial resources...
- A \$2 billion special investment fund will be created with the participation of state and international financial institutions to develop small and medium enterprises.
- A special innovation investment fund will be established, attracting funds totaling \$1 billion and investing in new technologies.



Regional Projects and Infrastructure Development





Anaklia Port - According to the **Marshall Plan, 1**6,000 jobs will be created at the Anaklia Port and Special Economic Zone. With investments from far Eastern countries and Japan, high-tech production will begin in the Special Economic Zone.

Kutaisi - A logistics and financial hub, where an international stock exchange will be established. A strong international logistics center will be built around the airport, and an efficient cargo transportation system will be developed.





Batumi - A center for the maritime industry and tourism, where a Georgian shipping company will be established.

Kakheti - Four-season tourism. Globally, 50 million registered wine tourists spend \$30 billion annually. By attracting just 1% of this, wine tourism could bring Kakheti a benefit of 1 billion GEL, providing an additional income of 10,000 GEL for every farmer.





Kartli - A center for agro and bioproduction. Strong Georgia aims to export products worth \$1 billion, with the state providing financial support for agro and bioproduction.

Racha - A center for international educational school campuses and the establishment of infrastructure for language, information technology, and international schools.





AGRICULTURE

- Consolidation of farms by combining citizens' resources to increase their income.
- Enhancing the accessibility of natural resources for the population.
- Reducing dependence on imported agricultural products and promoting local production.

Today, agriculture is not a business. Agriculture should become a source of income! Almost all branches of agriculture are characterized by very low productivity. The reason for this, in addition to small plots of land, is the lack of knowledge, incorrect selection, and non-compliance of export products with European standards.

We consider it a necessary condition for the development of agriculture according to the modern standard and becoming a source of income:



- Facilitating the pooling of resources through cooperation and managerial issues solving with joint efforts;
- Transfer of state-owned assets to citizens;
- Reducing dependence on imports. Promotion of local production and production of ecologically safe agricultural products.




TOURISM

Georgia – A Tourist-Attractive Country Year-Round:

- Gastronomic and wine tourism;
 development of festival, mountain-skiing,
 and equestrian tourism; promotion of cultural,
 historical, cognitive, as well as medical
 and balneological tourism;
- Development of tourism infrastructure tailored to specific segments in all regions.





TRANSPORT AND COMMUNICATION

- **Georgia as a Key Part of the Silk Road:** Georgia will be a significant part of the Silk Road, including energy, transport, and telecommunication (digital) corridors.
- Georgia as an Air Cargo Hub: Strengthening national passenger and cargo carriers.
- Development of High-Speed Railways:
 Routes including Baku-Batumi and Yerevan-Batumi.





ENVIRONMENTAL PROTECTION, CLIMATE CHANGE, AND ECOLOGICAL SAFETY

- Reducing risks from natural hazards and anthropogenic disasters, prevention measures, and fostering a resilient society in response to climate change will become a priority for the state.
- Implementing "green" policies and strict protection of ecosystems will be mandatory at all levels of decision-making. Furthermore, Georgia has the potential to become a producer of environmentally safe products. The economy will develop in accordance with sustainable development goals.
- The Ministry of Environmental Protection and Natural Resource Management will be established as a separate entity dedicated to protecting the environment, the health, and the lives of our population and future generations. This will include expanding protected areas, preserving biodiversity, managing waste correctly, and strictly controlling water, soil, and air quality.





Foreign Policy



- To ensure long-term peace and prosperity, Georgia will rapidly join the European Union. Peace will be reinforced by creating a model of security guarantors and by joining NATO. Georgia will take advantage of benefits available before accession, including a simplified transfer system for immigrants, increased exchange programs for students, and attracting membership funds for the benefit of all Georgian citizens.
- Georgia will become an economic bridge connecting Europe and Asia. The
 attraction of direct foreign investments will lead to the development of
 large, geopolitically significant infrastructure projects. Georgia will be a
 key node in global supply chains, and its long-term peaceful development
 will become a direct economic interest for global actors.
- Foreign trade will double. Georgia will effectively utilize the potential of the free trade agreement with the European Union. Visa-free travel will be established with the United States. Free trade agreements will be signed with the USA, Japan, South Korea, and Brazil. The existing trade regime with Georgia's neighbors will be maintained. Economic dependence on Russia will be reduced solely through increased trade turnover with other partners and by offering better trade alternatives for individuals.



PEACEFUL CONFLICT RESOLUTION AND DE-OCCUPATION

- Providing better education and employment alternatives for the population in occupied regions than those offered by their occupier, Russia. Increasing access to opportunities stemming from EU candidacy, visa liberalization, and free trade with the EU.
- Creating economic and trade zones for citizens living along the occupation line. Providing opportunities for participation in major infrastructure projects. Encouraging trade and business relations along the occupation line.
- Establishing security mechanisms (including video surveillance systems)
 for the population living near the occupational division line.

NATIONAL SECURITY POLICY



- Reforming and systemically strengthening the National Security Council.
- Improving the quality of parliamentary and civilian oversight of the defense and security sector.
- Establishing a national security system based on NATO's best practices, taking into account Georgia's location, general and specific risks, occupation, and other challenges facing the country.



NATIONAL DEFENSE

- A commission will be established in the Parliament of Georgia to achieve broad public consensus on the defense model, its resource provision, and development issues. This commission will develop political guidelines for the National Security Council and the Ministry of Defense for the preparation of national-level conceptual documents.
- Political dialogue and practical cooperation with NATO will be deepened to ensure rapid accession to the North Atlantic Alliance and compatibility.
 Dialogues with partners, primarily the United States, will be initiated to develop effective mechanisms for defense cooperation, such as joint trainings, rotational forces, etc.
- Long-term procurement of new defense weapon systems will be implemented. Territorial defense forces will be established nationwide based on the National Guard, and voluntary organizations will be integrated into a unified operational picture.

STATE SECURITY SERVICE REFORM

 To ensure national security, the depoliticization and reorganization of the State Security Service (SSS) is necessary. Ensuring a secure environment for the state and each citizen means creating a strong institution that serves the state, not the ruling party.



- The SSS should be stripped of the authority to prevent, detect, and combat corruption. An independent state body equipped with investigative functions—the National Anti-Corruption Agency—will be established, which will be accountable to Parliament and whose decisions will be made public.
- Illegal surveillance and monitoring in the country must end. Support is given to the adoption of the "Lustration Law". Any candidate appointed to the state security system must be subject to the requirements set by the "Lustration Law".

CRISIS RESPONSE SYSTEM

- In accordance with NATO's Warsaw Summit recommendations of 2016, a civil preparedness system will be established to address both natural and man-made disasters.
- Geological services will be established in local governments to assess the risks of natural disasters and implement damage prevention systems.
- Construction standards will be tightened with a focus on safety principles, monitoring, and strict control systems.





VETERANS

 The experience of veteran senior officers will be considered in the development and implementation of defense policy.

 The veteran's living subsidy will be aligned with the subsistence minimum, and the veteran's annual income - up to 9000 GEL will be exempt from income tax.

 "Veteran Houses" will be established, based on the principle that no veteran should be without housing.



HEALTHCARE

Main Objective: Long and Healthy Life

- Every citizen of Georgia should have access to comprehensive, quality, and timely medical care. Each citizen should have a qualified and motivated family doctor, both in urban and rural areas.
- Continuous education will be provided to medical personnel (doctors, nurses, lab technicians, and other healthcare workers) to enhance their qualifications.
- An adequate funding model for the healthcare system will be implemented; insurance companies' involvement in solving health issues will be significantly strengthened; reforms and demonopolisation of the pharmaceutical market will be carried out.





SOCIAL POLICY

Creating a Caring System for People

 Our primary concern is to ensure that labor is valued – any able-bodied person should live with dignity and not fear the future. A fair assistance system for socially vulnerable individuals should be established.



- The local labor market will become transparent and dynamic, allowing people to not fear losing their jobs and have opportunities for professional growth and retraining.
- Pensions will be raised to 1000 GEL, replacing the current amount, which in essence is more of a benefit than a pension.

EMIGRATION

- Creation of a unified national information base on emigration and registration in the nationwide population census. Opening of polling stations and ensuring voting rights.
- Establishment of a permanent advisory council with successful emigrants, scientists, and businessmen to facilitate investment, knowledge, and technology transfer to the country.
- Development of preferential tax conditions and special mortgage programs for individuals returning from emigration who wish to start a business.





INTERNALLY DISPLACED PERSONS

- The process of restoring/maintaining/granting citizenship for displaced persons will be simplified.
- A 5-year plan will be developed to provide all displaced persons with adequate housing. The 45 GEL allowance will be equalized with the subsistence minimum.
- The Law on Restitution will come into force, granting displaced persons ownership of real estate in Abkhazia and Samachablo (Tskhinvali region).



LAW ENFORCEMENT SYSTEM

Independent Judiciary

- A special process for verifying judges' integrity, is known as vetting.
- Filling all vacancies in the judiciary to expedite case hearings and reducing case review timelines.
- Reduction of the High Council of Justice's powers and elimination of the so-called transfer of judges.







MINISTRY OF INTERNAL AFFAIRS

- Full depoliticization of the police; the police should serve public order rather than the interests of the ruling party.
- Establishment of a fair and effective law enforcement system trusted and respected by the public.
- Creation of an independent investigation bureau.

PROSECUTION

- Election of the General Prosecutor by a 2/3 majority in Parliament.
- Increase in the independence of prosecutors in the execution of prosecutorial powers.
- Real parliamentary oversight of the prosecution's activities.







FIGHT AGAINST CORRUPTION

- Creation of a national anti-corruption agency with investigation functions.
- Confiscation of unjustified assets acquired through corruption.
- Fundamental reform of the state procurement system and ensuring transparency of offshore companies.

PENITENTIARY SYSTEM

- A penitentiary system focused on the resocialization of convicts.
- Objective and transparent mechanisms for early release.
- Dismantling of the criminal authority institution.





Public Service Reform

- Digitalization of all governance areas to enhance the quality and accessibility of public services, improve services, reduce administrative costs, and increase transparency.
- Elimination of nepotism, ensuring fairness and transparency in public service entry and career advancement, and removing political pressure on public servants.
- Privatization of state enterprises and removal of public officials from activities involving corruption risks.

Regional Policy and Local Governance

- Real decentralization, increased funding and powers for municipalities, councils for the people, and local budgets tailored to population priorities.
- Harmonization of local governance legislation and management with the best European standards.
- Reforming administrative-territorial arrangements for greater public involvement in self-governance, creating a system of cooperation between municipalities at the regional level, and abolishing the governor's institute.





EDUCATION

Georgian Education = European Education

- Equal access to quality education at preschool, school, higher education, and vocational training levels.
- Liberating the system from governmental and partisan pressure through real decentralization and public participation.
- Establishing European standards for everyone, with well-developed infrastructure, valued pedagogical personnel, a well-organized school nutrition system, and student housing.

CULTURE

Creative Georgia – Strong Georgia in the European Union

- Developing national strategy for Georgian Culture with the involvement of professional circles, based on the establishment of institutional independence, transparent funding models, legislative guarantees, and enforcement mechanisms;
- Culture for Everyone Stimulating the creative economy and increasing accessibility to culture across the country;
- Preservation of cultural heritage sites and creation of a special state program with the involvement of scientific circles, considering high international standards and obligations.







SPORTS

Georgia - A Country of Champions

- Development of mass sports; Accessible sports complexes and pools in every major city and municipality;
- Establishment of academies for major football clubs in Georgia (following the example of Juventus Academy in Tsalenjikha);
- Introduction of swimming, and alpine skiing lessons for students; promotion of equestrian and mountaineering clubs.





EQUALITY

From Constitution to Reality

- All people will be equal before the law;
- The rights of non-dominant groups will be protected;
- Constitutional equality will become a reality.





PEOPLE WITH DISABILITIES

Georgia - A Country Without Barriers

- Businesses will be granted benefits for employing people with disabilities;
- Opportunities for employing people with disabilities in public service will be increased;
- Creation of an adapted environment and transition from a medical to a full social model.



ETHNIC MINORITIES

Multiethnic Strong Georgia

- Increasing representation of minority groups in decision-making and implementation processes through political empowerment;
- Strengthening and increasing access to the teaching of the Georgian language through state funding and the provision of diverse services;
- Protection and development of multicultural religious-cultural heritage by granting it national value.





WOMEN:

A Strong Woman for a Strong Georgia

- Tackling women's poverty through economic empowerment, equal pay, and paid maternity leave.
- An uncompromising fight against violence against women in public and family settings, with legislative and executive guarantees.
- Political empowerment of women—more women in leadership!



YOUTH

Georgia - the country of opportunities for youth


- 6-month paid internship for graduates with mutual cooperation of educational institutions and public and private sectors;
- Financial support of students by promoting entrepreneurial activities and exempting them from income taxes; Increase of professional, educational service centers coverage in regions;
- Gradual and painless rejuvenation of the public sector with transparent and objective competition conditions, prevention of elite corruption and nepotism.





DRUG POLICY

- Uncompromising fight against narcotic drug dealers and pharmacy drug addiction;
- Implementation of institutional mechanisms for primary prevention; increasing the number of specially trained psychologists and social workers in educational institutions;
- Transition from punitive policy to care-prevention. Bringing existing drug rehabilitation spaces funded by the state closer to EU standards. Creation of regional treatment and rehabilitation centers for drug addicts.
